### **TRAILER BRIDGE AWARDED EXCLUSIVE MULTI-YEAR CONTRACT BY COSTCO**

**Jacksonville, FL - February 4, 2008 -- Trailer Bridge, Inc. (NASDAQ Global Market: TRBR)** today announced that it has won an award to be the exclusive carrier for all Costco Wholesale Corporation shipments moving in dry containers to Puerto Rico. This represents new business for Trailer Bridge except for a small number of trial shipments started in mid-2007. Costco operates a large chain of membership warehouses, including four warehouses currently in Puerto Rico, that offer one of the largest product category selections available to consumers.

Shipments under the new contract are anticipated to commence in April 2008. The expected overall revenue is confidential under the terms of the contract but the container shipments are initially expected to be approximately 5% of Trailer Bridge's southbound container volume. It is a multi-year award and volume is anticipated to grow over that time based upon the historical relative growth of Costco in the Puerto Rico market.

"We are delighted with this award from one of the largest and most knowledgeable shippers in the lane. Costco tested our services and went through an intensive and lengthy review of our system and processes prior to making this decision. I believe this exclusive, multi-year award speaks for itself in terms of the service and value we provide to professionals such as Costco and the operational leverage available to service additional business," said John D. McCown, Jr., Chairman and CEO. "In any thorough analysis of our unique integrated 53' marine model, we exhibit cost-effective solutions above those of our competitors in the lane. For Puerto Rico and Dominican Republic shippers seeking to build competitive advantage through their freight provider selection, Trailer Bridge offers a long term business relationship that can benefit all parties including the end consumer."

Trailer Bridge provides integrated trucking and marine freight service to and from all points in the lower 48 states and Puerto Rico and the Dominican Republic, bringing efficiency, service, security and environmental and safety benefits to cargo in those

This total transportation system utilizes its own trucks, drivers, trailers, containers and U.S. flag vessels to link the mainland with Puerto Rico via marine facilities in Jacksonville, FL, San Juan, PR and Puerto Plata, DR.
